COACHING PHILOSOPHY:

My coaching philosophy is to develop a winning team by incorporating a strong work ethic and team work. This will allow for all of the players to have fun, develop their hockey skills and enjoy the camaraderie that team work brings not only to sport, but to their day to day lives. I believe that it is important that all members of the team enjoy a sense of belonging and that each of their individual roles on the team are as important as the next. I feel that coaching is about mentoring and allowing our youth to learn in a comfortable setting while working as hard as they can and pushing themselves to get better each day.

ROLE OF COACHES:

The role of the co-coaches, assistants, manager, and trainers will be very involved. The other members of the coaching staff are all integral members of this team and have been specifically chosen for their level of contribution.

TEAM INITIATIVES, OBJECTIVES, AND GOALS:

Team initiatives will be to foster a team with good communication, trust, accountability, and commitment to one another and the team. Respect for their coaches, their team mates as well as for themselves.

The objectives will be to teach the players 'Fair Play', how to improve their skills, work as a team, work from whistle to whistle and outplay the other team. The team's goals will be to not only learn and improve their hockey skills, but to also learn and improve on their life skills.

ICE TIME

The goal would be for everyone on the team to share in an equal amount of ice time, however game situations will dictate shift changes. This would refer to power play, penalty kill, close games, need to pull goaltender etc... we won't be timing shifts due to the fast pace of the game and variances will simply occur. Performance at games and at practices will dictate playing time. Be prepared that if you miss practices or present with a negative attitude, you will sit during games.

FEES

Rep fees: \$245 payable up front in two increments with post dated cheques: \$145 due October 31st and \$100 due January 15th. This also covers 1 set of rep socks and concussion testing this season. Tournament Fees: Approximately \$300.00/player (not including Montreal) to be discussed in detail.

TEAM RULES AND EXPECTATIONS

Team Mission will be to enjoy 'Fair Play' and the great game of hockey while working as hard as you can to foster a team environment that works together to excel not only on the ice but off. To improve and develop hockey skills as well as teamwork.

All team members will be respectful of their families, their community, their coaches, their teammates, their opponents, and themselves. The team consists of players, parents, and coaches.

- 1. Each player and coach will be expected to attend games wearing a shirt, tie, black dress pants and Otter jacket of choice.
- 2. Each player and coach will be expected to attend games a minimum of 60 minutes prior to the start of the game and be ready for play 30 minutes prior.
- 3. Each player and coach will be expected to attend practices 30 minutes prior to the start of the practice, and be ready for play 10 minutes prior.
- 4. If a player is unable to make a game or practice, they are expected to contact the team manager a minimum of 24 hours in advance. Any holidays or family commitments should be sent in writing to the manager as soon as you know your dates in order that we always have enough players to ice a team for games and tournaments.
- 5. Each team member will support the team philosophy and treat every team member as an equal. If a member is having difficulty, then it will be expected that everyone help that member rally past that issue.
- 6. Each player and coach will be expected to participate fully during practices and games, especially during skating practice. Remember that practice should always be harder than a game. Practice makes permanent!
- 7. Each player and coach will clean up after themselves in the dressing room.
- 8. Each player will be expected to offer assistance to the coaches on a rotating basis to fill water bottles, carry pucks, collect jerseys, etc.
- 9. Each team member will be expected to be respectful off of the ice and to work as hard as they can in school to achieve their best results.
- 10. Each member will be encouraged to approach their coaches or teammates if they are having difficulty with anything for assistance.
- 11. Foul language will not be permitted off the ice, in the dressing room, on the ice, or in the stands.
- 12. Each team member will be expected to accept an official's decision and allow the coaching staff to discuss that decision should it be warranted.
- 13. Parents are expected to adhere to the 24 hour rule regarding any conflicts that may arise. After the 24 hours, you are to e-mail the manager with your issue and you will have a reply within 24 hours from the coach.
- 14. Parents/Guardians will not be permitted in the dressing room unless there is an injury to their child.
- 15. Coaches and parents will be expected to support all the players of the team. It is expected that everyone on the ice, on the bench, and in the stands will be positive representatives of their communities to fulfill the Team Mission.
- 16. Discipline, if necessary, may include reduced ice time, removal from a game, and or team suspension if warranted.

Your coaching staff are there to teach and help the team have a great year of hockey. This will be possible with the assistance of all team members. All members of the team are accountable to one another.

If you wish to participate on this team this season and are prepared to commit to the plan and principles described above, you must return a signed copy of this letter to me prior to stepping onto the ice for the next ice time. Please discuss this with your parents and/or guardians before making this commitment.


